

1	SP2.4	<p>We understand that the timely submission of the hard copies (original plus three copies) of the PQ document will automatically result in the submission of a further softcopy through a download link.</p> <p>In the light of our current experience with courier services to Ramallah we are very much concerned about a timely delivery of the documents. Courier services are not able to provide reliable timing information nor guaranteeing the proper receipt.</p> <p>We are therefore seeking for a more reliable option to submit the hardcopies. We would like to suggest the submission to the Employer or optionally to the Tender Agent - as it was done in other cases.</p>	<p>Submission via hard copy as per SP 3.2.1 cannot be avoided due to national regulations.</p> <p>Please be aware that according to GP 1.4.1 and GP 2.2.1 (b), the bidder can nominate an authorized representative in the form of a written power of attorney to sign and submit the application on behalf of the applicant as instructed in the PQ document.</p> <p>In order to facilitate hard-copy submission for international bidders, we will – on an exceptional basis - accept the timely submission of the signed Original Power of Attorney in line with GP 2.4.1 to the address of the Tender Agent – if required – as follows:</p> <p>Sophia von Dobschütz Gewerbegebiet Schwabering 13 83139 Söchtenau Germany</p> <p>In this case, the following documents shall be submitted with the Original Application to Ramallah as instructed in GP 2.2.1 (b):</p> <ul style="list-style-type: none">• a copy / scan / picture of the signed Original Power of Attorney• a written proof (e.g. by the post delivery service) that the Original Power of Attorney was delivered on time (specifying the date and time of delivery) at the above-mentioned address.

Given the current circumstances and the extreme difficulty of sending documents by post in the region, would it be possible to submit bids electronically (e-mail, platform or other)?</p>	<p>Please see Answer No. 1 above.</p>
3	SP 3.2.1	<p>We kindly ask for a 10-days extension of this deadline (12.02.2024) with regard to the outstanding clarification to our request dated 15.01.2024. We are also facing difficulties in timely contacting and negotiating with partners and individual experts with regard to the Gaza-war.</p>	<p>The Application must be submitted on or before Monday, 4th March, 2024 at 12.00 hrs pm, local time in Ramallah, Palestine (GMT+2).</p> <p>Please be aware of GP 3.2.2 mentioning “all rights and obligations of the Employer and the Applicants subject to the previous deadline shall thereafter be subject to the deadline as extended.”</p>

4	SP 4.2.3	Please confirm that the applicant must have a minimum number of 25 staff to be counted under Form 6 no.2 (quantitative capacity)	Partially confirmed. The applicant must have 25 staff to receive 0.25 pts. In order to receive the maximum points of this category (max.1 pt), the bidder requires 4 x 25 staff = 100 staff.
		Please confirm that out of the 25 total number of staff, 10 staff with the required specializations must be counted.	Partially confirmed. Similar as per (a) above, the applicant must have 10 staff with the required specialization to receive 0.5 pts. In order to receive the maximum points of this category (max.2 pts), the bidder requires 4 x 10 staff = 40 staff with the required specialization.
		Could you please clarify the quantitative scoring: according to 2.2 max. five points are available under Form 6. No.2. The detailed scoring according to the sub-criteria however reveals that points will be given per each staff which does not match.	As described in SP 4.2.3, the sub-criteria listed under 2.2. (i) language skills, (ii) Palestinian requirements, (iii) KfW requirements, and (iv) ESHS-Experts will be evaluated based on Form 6. No.1 (not Form 6. No. 2 as understood from your side). These criteria will receive up to max. 5 points. The remaining sub-criteria listed under 2.2. "extent to which the Applicant has access to personnel" will be evaluated based on Form 6. No.2 and will receive up to max. 5 points.
