1	Given that we can now upload the EOI document on the Exficon platform, are we right to assume that there is no need to submit the original Application document to the Employer?	Not confirmed. Neither the PQ-document, not Addendum No. 1 mentions that upload via Exficon is applicable in this tender. Please follow the instructions of the PQ-document clearly mentioning in SP 2.4.1 and SP 3.2.1 that the original Application and copies have to be submitted in Ramallah at the address specified in SP 3.2.1.
		Please note that SP 2.4.1 mentions "Nevertheless, immediately after opening of the hard-copy Application document, you will be contacted via e-mail to upload a soft copy of the Application document on an upload link. The soft copy must be a PDF file which is suitable for character recognition and which is searchable and unalterable (no scanned files)." The mentioned upload link is not via the exficon platform, and is only to avoid potentially jeopardizing the timely delivery by custom authorities due to soft copies via CDs, DVDs, USB-sticks or similar. The mentioned upload link (One Drive Link) will be shared by the Tender Agent only after opening. Only Applicants that successfully submitted their documents in Ramallah at the address specified in SP 3.2.1 and complaint with the provisions in the PQ-documents will be contacted via e-mail by the Tender Agent.
